

## INTERIOR DESIGN AT THE RESIDENCES AT MANDARIN ORIENTAL, ATLANTA, WINS GEORGIA ASID DESIGN EXCELLENCE AWARD

GraysonHarris' Winning Design Receives Gold Award in Residential Category

**ATLANTA (May 27, 2014)** – On May 8, the Georgia chapter of the American Society of Interior Designers (ASID) presented the Design Excellence Award to GraysonHarris Interiors + Design for the firm's work on the model unit at The Residences at Mandarin Oriental, Atlanta. The Residences are an affiliate of real estate company iStar Financial Inc. and are managed by Mandarin Oriental Hotel Group.

The full-service interior design firm received the Gold Award for "Residential – Residence Under 3,500 Square Feet." The project will be entered in the national contest later this year.

Decatur, Ga.-based firm GraysonHarris, a partnership between Andrew Harris and Grayson, decorated the lavish three-bedroom model home, which was unveiled in September 2013 and featured in the November 2013 edition of *Atlanta Homes & Lifestyles*. Harrison Design Associates designed the home, staged on the 45th floor, to demonstrate The Residences' new contemporary appearance.

"We carefully selected art, furniture, fabric, lighting and accessories that celebrate the notion that 'life is art,'" said Harris. "Each piece either stands on its own as art or complements to create a seamless, sophisticated palette. The result is a very urban and chic aesthetic, suitable for anyone who appreciates art, entertaining and living well."

The interior design featured subdued but richly textured fabrics to create a backdrop for sculptural furnishings and lighting. The art selections were bold and graphic to provide focal points. The furniture layout reinforced the strong geometry developed by the architects, while establishing a highly unexpected yet functional, open and efficient plan.

The Residences' design incorporates contemporary, ultra high-end finishes and sleek, built-in fireplaces with marble surrounds. Each Residence will also feature a 36-inch Viking gas grill as well as a gas fireplace on its 300-square-foot outdoor terrace. The common areas include modern color palettes and sleek flooring. The Residences are the only condominium residences in Atlanta to feature Miele appliances.
